Donating your old vehicles will allow you to take a tax deductions. However, if you donate it to a charity, the blue book value is not that to which you are entitled. Most charities do not have the wherewithal to sell those vehicles because the tax credit is based on the amount actually received by the charity. Most charities use brokers who then pay back to the charity what they say is the net after expenses, etc. Thus, a charity may only receive \$25 to a couple of hundred dollars for an auto that has a blue book value of substantially more. The donator is only entitled to the amount actually received by the charity which most often is quite a bit less than the blue book value.

DANGERS OF REO'S TODAY- Just this past few weeks GMAC Mortgage, BOA and JP Morgan Chase halt their foreclosures due to a scandalous finding. Senator Dodd has called for senate hearings to sort out the fraudulent paperwork that created a rush and deluge of foreclosures. The serious problem is that a company in the midst of the foreclosure process actually created missing documents and forged signatures of the property owners. The courts have found that the chain of title for most of these foreclosures was broken and thus there is no proof of who owns the property and what was intended in the transfers. At the head of the problem is MERS, Mortgage Electronics System, which is owned by some of the largest banks and Fannie Mae and Freddie Mac. It is charged with initiating and completing foreclosures for the banks. Unfortunately, there was such an influx of foreclosures, that it couldn't handle the avalanche. This started the problem of creating fraudulent documents. The problem is further exacerbated when you add the REO (real estate owned) purchases with the purchasers conceivably not having legal ownership to the properties. So, be very careful if you own an REO or are in the market to buy one. Very close and certain title is necessary. Watch for any caveats relieving sellers, banks, etc., from any responsibility of a fraudulent transaction.

To give an idea as to the impact these activities can have. It was projected that there would be over 1.2 million foreclosures in 2010. This is not likely to be reached due to the moratorium on foreclosures by some of the major lenders. The July—September quarter saw the largest foreclosure numbers for that period since the housing market collapsed in 2006. For the 2010 quarter there were 288, 345 properties lost to foreclosure in the U.S which is up from 270,000 during the preceding quarter. So, there will be families who are receiving a reprieve and hopefully can benefit by the moratorium. It is anticipated that the freeze on foreclosures could postpone at least, 30 % of all home sales for that period.

DEFICITS & UNEMPLOYMENT– Good news and bad news! Jobless claims rose to 462,000 from an expected of 445,000 last week. However, the number on the unemployment roles fell 112,000 to 4.399 million which is the 2nd lowest since November 2008. However, this doesn't account for the number of unemployed who no longer can collect benefits. Odd, isn't it, the number who don't collect but are still unemployed is never published! Couple this with an August jump of 8.8% traded deficit increase to \$46.4 billion with the largest deficit of the U.S. to China at \$28 billion, and we have a very dismal economic outlook.

Oddly, if you couple the foreclosure problem addressed above with these economic stats, one can realize that the real estate market is not going up by any means. So, sit tight and don't make any major decisions just yet.
